RECOMMENDATION

Adopt five Resolutions authorizing the City Manager or her designee to execute any resultant revenue agreements and amendments with Alameda County to provide congregate and home-delivered meals, family caregiver support, senior center activities and information and assistance services to seniors for the following programs for Fiscal Year 2021:

- 1) Congregate Meals in the amount of \$43,695;
- 2) Home Delivered Meals in the amount of \$50,954;
- 3) Family Caregiver Support Program in the amount of \$39,499;
- 4) Senior Center Activities in the amount of \$22,840; and
- 5) Information and Assistance Services in the amount of \$49,548.

FISCAL IMPACTS OF RECOMMENDATION

The City of Berkeley will receive five grants totaling \$206,536 from Alameda County Area Agency on Aging for FY 2021 for the programs listed below. The contracts require matching funds totaling \$567,730 as detailed below, and the Division will utilize General Fund in its approved FY 2021 budget to provide the match. The grant budgets will be adjusted to match the contract amounts and these changes will be included in the First Amendment to the FY 2021 Annual Appropriations Ordinance.

1. **Congregate Meals:** ERMA GL Code 011-51-505-549-2041-000-444-various. The FY2021 contract is for \$43,695 and supports staff coordination and management of home delivered meals. The contract requires a match of \$24,113 (10% of total project budget minus County general fund).
2. **Home Delivered Meals:** ERMA GL Code 011-51-505-549-2044-000-444-various. The FY2021 contract is for \$50,954 and supports staff coordination and management of home delivered meals. The contract requires a match of \$37,024 (10% of total project budget minus County general fund).

3. **Family Caregiver Support Program:** ERMA GL Code 011-51-505-541-2036-000-444-various. The FY2021 contract is for \$39,499 and supports caregiver outreach, training and respite services for care receivers. The contract requires a match \$13,794 (25% of total project budget minus County general fund).
4. **Senior Center Activities:** ERMA GL Code 011-51-505-544-2069-000-444-various. The FY2021 contract is for \$22,840 and supports staff coordination and delivery of senior center outreach, activities, classes, and special events. The contract requires a match of \$2,132 (10% of total project budget minus County general fund).
5. **Information and Assistance Services:** ERMA GL Code 011-51-505-541-2035-000-444-various. The FY2021 contract is for \$49,548 and supports staff management and delivery of information, assistance, referral and follow-up services. The contract requires a match of \$4,920 (10% of total project budget minus County general fund).

CURRENT SITUATION AND ITS EFFECTS

In February 2018, Alameda County issued a request for proposals for caregiver, senior center, information and assistance, and nutrition services. The City of Berkeley applied for this funding and received notification of grant awards for caregiver services, senior center activities and administration of Senior Nutrition Programs on April 13, 2018 for a four-year period.

Throughout the COVID-19 pandemic, the Aging Services Division has continued to meet the needs of our older adult population. Our Congregate Nutrition program has shifted from in person to daily delivered lunches to all senior center participants. Our Meals on Wheels program continues to deliver daily lunches to our homebound elderly, and has expanded its client base from approximately 140 pre-COVID to 220 currently. Our Senior Center Activities program will shift to provide online classes and workshops in partnership with Berkeley Adult School. The Information & Assistance program has shifted to provide resources and referrals to older adults via phone. And finally, our Family Caregiver Support program continues to provide caregiver resources and training by phone, and will shift to provide caregiver support groups via the Internet. The aforementioned program changes have been implemented in partnership with the Alameda Area on Aging in order to continue to serve our high-need, vulnerable older adult community.

BACKGROUND

The City of Berkeley receives funding from city, county and state sources as well as private donations to serve senior residents of Berkeley, and to coordinate the Tri-City Nutrition Program. The Department of Health, Housing & Community Services is committed to providing a broad range of community services, including services to meet the needs of seniors in the community. The Aging Services Division provides nutritious

meals, outreach, activities, social events, classes, and individual support and referral services to seniors and their families in the community.

ENVIRONMENTAL SUSTAINABILITY

The home-delivered and congregate meal programs composts meal waste.

RATIONALE FOR RECOMMENDATION

These funds support the City's senior centers and meals programs, and provide critical support to ensure the Aging Services Division can continue to provide services at the North and South Berkeley Senior Centers, and Senior Nutrition Programs.

ALTERNATIVE ACTIONS CONSIDERED

The Aging Services Division assesses each funding source to ensure that it supports the City's mission and goals. The alternative action of not seeking any of these funding sources would result in a significant reduction in services available to seniors in the community.
